1. CATALOG DEADLINE: FRIDAY, NOVEMBER 8TH AT 5:00 PM CST.

2. COMMISSIONS: Selling 8%. No Sale 8%. \$8 Per Hd. Minimum. \$1 Per Hd. Yardage. \$1 Per Hd. Vet. State and Federal check-offs apply.

3. BRED EWE REQUIREMENTS: Minimum of 3 head consigned. Must be 5 years of age and younger with sound body condition, feet and udders. Wool breeds must be short pelted or shorn prior to sale. Pregnancy test by ultrasound or blood test is required. Ewes may be pregnancy tested by an accredited veterinarian prior to sale day - stamped vet statement with ear tags matching results must be turned in at check-in. Sales Barn veterinarian will be on site to ultrasound the day before the sale (Mon. Nov. 26th). Ewes need to be 30-90 days along to ultrasound by Sales Barn vet. Charge is \$10 per Hd. deducted from sales check.

4. REPLACEMENT OPEN EWE & EWE LAMB REQUIREMENTS: Minimum of 3 head consigned. Must be 5 months - 3 years of age. Sound feet and body condition. Wool breeds need to be short pelted or shorn prior to sale.

5. REPLACEMENT RAM & RAM LAMB REQUIREMENTS: Must be 5 months - 3 years of age. Sound feet and body condition. Wool breeds need to be short pelted or shorn prior to sale.

6. SUBSTITUTIONS & NO SHOWS: No substitutions. No show fee \$20 per Hd. Consignor will not withdraw or privately sell consignments before the sale. In the occurrence of sickness or death, stamped and written vet statement must be provided no later than 10:00 AM on sale day.

7. SCRAPIE TAGS: All consignments must have an official USDA scrapie tag placed in ear prior to sale.

8. REGISTERED STOCK: Registration papers and signed transfers must be in order and turned in at check-in. Registration papers not turned in, not in order or forgotten at home - animals will be sold as commercial. Registration papers are transferred to the buyer by the office.

9. CHECK-IN: Monday, November 25th: 8:00 AM - 8:00 PM. Sale Day, November 26th: 6:00 AM - 10:00 AM.

10. PENNING - FEED & WATER: Pens with sawdust will be provided and assigned by sales staff. Consignor is responsible for the feed & watering of animals.

11. Any animal not meeting sale requirements or declared unsound by sales staff will be held for the regular sheep sale on Wednesday, November 27th.
